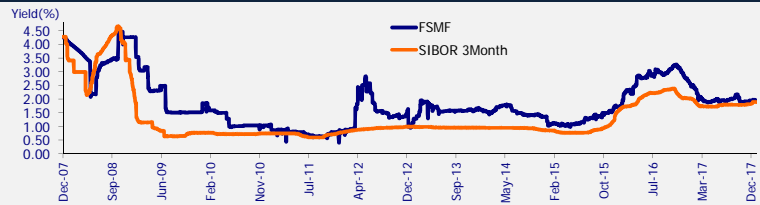

Performance Fund vs Benchmark



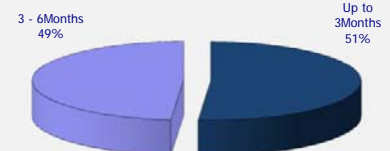
