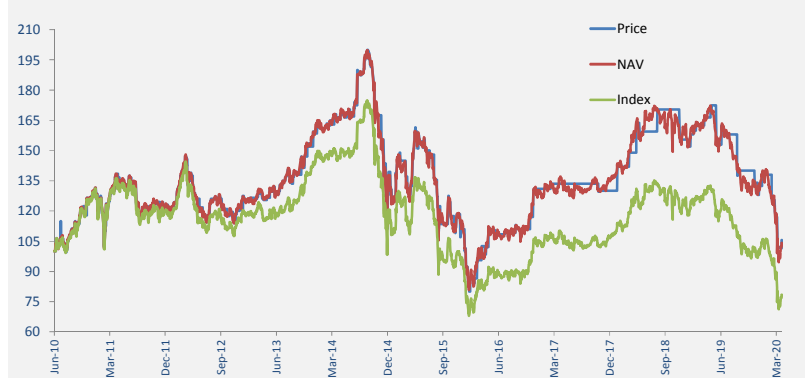

Performance Fund vs Benchmark

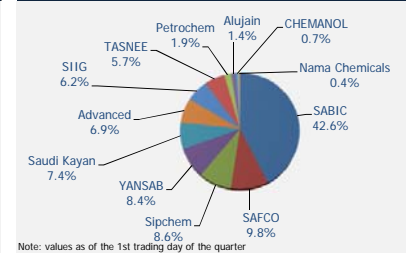
